**SETTLEMENT AGREEMENT**

Dusty Bottle, LLC ("Licensee") received a September 11, 2015 Notice of Hearing directing it to appear before the Liquor Control Board ("Board") on October 14, 2015 at Montpelier, Vermont for a contested case hearing to consider the suspension or revocation of its First and Third Class Liquor Licenses and has reached an agreement with the Department of Liquor Control ("DLC") to settle the violations alleged against it, specifically: violations of General Regulation Nos. 16 (2 counts), 37 (1 count), 49(a) (1 count) and the Board's April 1, 2015 Order prohibiting service of alcoholic beverages past 1:00 a.m. each business day (30 counts).

The Board has agreed to accept, and shall impose upon Licensee, the following sanction:

- **SUSPENSION OF LICENSEE'S FIRST AND THIRD CLASS LIQUOR LICENSES FOR TWENTY (20) CONSECUTIVE DAYS BEGINNING AT THE OPENING OF BUSINESS ON SUNDAY, NOVEMBER 1, 2015 TO AND THROUGH TO THE OPENING OF BUSINESS ON SATURDAY, NOVEMBER 21, 2015. THE BOARD'S APRIL 1, 2015 ORDER, NAMELY THAT SERVICE HOURS SHALL END AT 1:00 A.M. EACH DAY. REMAINS IN FULL EFFECT AND ANY ADDITIONAL VIOLATIONS MAY RESULT IN REVOCATION.**

Licensee acknowledges and agrees that, at all times and in all communications and proceedings related to this matter and to this Settlement Agreement, it has had the right to be represented and advised by legal counsel and has elected to proceed without legal counsel. Licensee agrees and understands that, by executing this Settlement Agreement, it is waiving any right to a hearing related to the Notice of Hearing (thereby waiving any right to be presented with the evidence against it, to cross-examine adverse witnesses, and to offer evidence of its own to contest the DLC's allegation(s)) and waiving any right to challenge the jurisdiction and continuing jurisdiction of the Board in this matter. See 7 V.S.A. § 236; 3 V.S.A. §§ 809, 814.
