

RE: HEARING TO CONSIDER THE SUSPENSION OR REVOCATION OF THE FIRST AND THIRD CLASS LICENSES GRANTED TO **DURNEYS CAFÉ BISTRO & BAR, LLC**, 133 EAST MOUNTAIN ROAD, KILLINGTON, VERMONT SAID LICENSES BEING GRANTED TO SELL ALCOHOLIC LIQUOR FOR ON-PREMISE CONSUMPTION.

Please take notice that pursuant to the authority vested in the Vermont Liquor Control Board by Title 7, Section 236, Vermont Statutes Annotated, a hearing will be held before the Liquor Control Board at the Department of Liquor Control.13 Green Mountain Drive, Montpelier, Vermont on Wednesday, April 17, 2013 at 9:30 a.m.

The hearing will be held as a formal hearing and will be held to consider the suspension or revocation of the first and/or third class licenses granted to **Durneys Café Bistro & Bar, LLC**, said licenses being granted to sell alcoholic liquor for on-premise consumption, for alleged violation of General Regulation Number 10, which is set forth and specified below.

General Regulation No. 10: No first or third class liquor license shall be issued to a person who is not first licensed with the Vermont Department of Taxes to collect the Vermont Rooms and Meals tax. Suspension of first or third class liquor licenses may result by action of the Liquor Control Board, after notice and hearing, upon certification to the Board by the Vermont Department of Taxes that the licensee has failed to collect the Vermont Rooms and Meals tax, has failed to pay over to the Vermont Department of Taxes the Vermont Rooms and Meals tax collected, or is not licensed with the Vermont Department of Taxes to collect the Vermont Rooms and Meals tax

It is alleged that the licensee is not in good standing with respect to any and all taxes payable to the Commissioner of Taxes in violation of General Regulation Number 10.

The Liquor Control Board shall determine whether or not such alleged violations did occur as specified herein.

Pursuant to Title 3, Vermont Statutes Annotated, Section 809(d), the said **Durneys Café Bistro & Bar LLC** shall have an opportunity by itself or through its attorney to appear at said hearing to present evidence and argument on all issues involved in this case and bring before the Liquor Control Board all pertinent facts that the said licensee believes will have a bearing on the issues involved in this case.
